President's report



After two hard years of lockdowns and border closures, the second half of this financial year has felt a little like getting out of jail (not that I have ever actually experienced that feeling).

I was fortunate that soon

after becoming President in August 2021 we were able to resume our Kabbalat Shabbat, morning Shacharit and Shabbat services as well as celebrate the Yomim Tovim in 2022, of course always with COVID-safe measures in place.

We celebrated Chanukah again with the children using our front lawn for an outdoor celebration and discovered through summer that our Friday evening Kabbalat Shabbat celebrations in Caulfield Park were so popular we were regularly attracting 60-70 people to enjoy our musical welcome to Shabbat, alongside the lake and ducks.

As I write this, we are preparing for Shavuot celebrations, Tikkun Leil and a whisky and cheesecake evening as well as a calendar of musical events and other activities leading up to Rosh Hashanah and Yom Kippur. It is heart-warming to again plan for a range of activities to engage our congregation.

Due to the strong support of our members, the Shule remains in a sound financial position and in fact we managed to grow membership during the pandemic.

As you all know, we farewelled Rabbi Ronnie Figdor after 10 years as CEO and just prior to his departure, he submitted his final application for a \$100,000 Victorian Government matching grant for urgently-needed capital works, which was successful.

In a similar vein, local Federal MP, Josh Burns (who was married in our Shule) contacted Rabbi Glasman and me just before the election to pledge, on behalf of the ALP, if elected, \$300,000 to upgrade our toilet

facilities throughout the Shule. Consequently, with a Labor Government now elected, we can look forward to those funds flowing to us in due course.

David Marlow was appointed to the position of Executive Director and preparing to hit the ground running for his 1 April start.

The Board scheduled a strategy day in late May 2022 to discuss and plan for the Shule's next three years and how to develop programs and activities to further engage the congregation and to secure our future despite the geographical challenges of being outside the 'Borscht Belt'.

In closing, I want to again thank Ronnie Figdor for his 10 years of service and for agreeing to continue to conduct our 2022 High Holyday services in the Samuel Myers (ADC) hall.

I want to sincerely thank our ministerial team of Rabbi Glasman, Rabbi Nagel and Chazzan Brett Kaye for their spiritual leadership and contributions to our beautiful services. I also want to thank Brett for his work with the choir which brings us a soulful and inspiring musical service every single week. I would also like to acknowledge Alick Mazin who took on the role of conductor with enthusiasm and a vigour that belies his age when services resumed.

Thank you also to the office team of Rita, Corinne, Erica, Karen, Amanda and groundsman Raymond.

A special thank you to John Slutzkin for overseeing the Aliyot and to Len Levy for helping with the call ups on 'game day'. I also want to thank Len for his hard work in maintaining our daily minyan and ensuring that anyone with Kaddish can come to our Shacharit services.

Finally, I sincerely hope that the coming year will be another one of freedom and normality.

Executive Director's report



Although I only joined as Executive Director on 1 April 2022, I have been a member for seven years and have seen the dome restoration project, Adele Southwick Centre renovation and kitchen renovations all take place over recent years.

The period of this report was one of lockdowns, online events and great difficulties, as we all coped through the COVID pandemic and restrictions.

Face-to-face events were frequently deferred or cancelled, as were several of our 150th anniversary celebrations, including the 150th Gala High Tea and planned Scout, Guide & Hebrew School and Bar & Batmi Reunions.

Despite High Holyday services taking place virtually for the second consecutive year, memberships help up reasonably well. We thank all our congregants and members for their support and loyalty through these stressful times. Our pre-Rosh Hashanah care packs delivered to member families were very well received.

The Shule leadership team appreciates the support of our members. Our ministerial and office staff have had to work hard and flexibly to respond to the rapidlychanging environment — open-closed, lockdowns, reopening with limited numbers, pre-registration for services, constant cancellation or changing of life cycle events and venue bookings, health and safety requirements, moving services online, all while working from home.

- Rabbi Ronnie Figdor OAM, for his leadership and creativity as CEO through the period.
- Rabbi Yaakov Glasman AM, Rabbi Hillel Nagel and Bat Mitzvah teacher Tali Koth for teaching Bar/Bat Mitzvah classes on Zoom to students who have "had a gutful" of remote learning.
- Rita Elbaz, whose days were spent calming the nerves of Bar/Bat Mitzvah parents or upset brides and grooms who yet again had to alter their plans, cancel more guests to limit their numbers, cancel caterers, cakes, stylists, etc.
- Rabbi Pesach Steinberg, who managed venue bookings and other key activities until he left us late in the calendar year.
- Bookkeeper Corinne, who had to constantly invoice, refund and reinvoice as situations and restrictions changed.
- Caretaker Raymond Landes whose on-again, off-again venue instructions were handled with extraordinary patience and calm.
- Karen Klein, who looks after communications and marketing, did a huge job on our 150th anniversary celebrations and drove the 150th commemoration book.

- Our Ministerial team led by Senior Rabbi Yaakov Glasman AM, Rabbi Hillel Nagel and Chazzan Brett Kaye are the jewels in the St Kilda Shule crown. They pivoted their work to run online shiurim, life-cycle events and even memorial minyanim so that families still felt connected.
- Volunteers Frankie Pinch (working on our 150th anniversary book) together with Lorette Brown and Rodney Phillips, and office volunteers Cecile Barr, Gerald Frank, John Karp, Abby Levy, Uri Rosenberg (who have been assisting with general office management and preparing historic materials).
- John & Beth Slutzkin had to repeatedly modify their trivia night. John, Len Levy and Paul Topol have been instrumental in keeping services running smoothly, either as gabbaim or in assisting the President with a weekly honours list or ensuring that the daily morning services continued to run — for much of the year, on Zoom! Danny Goldsmith and Noel Levin OAM again had to contend with organising a volunteer security roster, then cancel them, then reschedule. The greatest thanks you can give to them is to register for our volunteer male and female Shule protectors.
- Our Board members (listed separately), who have had to grapple with many decisions that previous Boards have not faced through COVID and restrictions.
- Our choir (listed separately) with leadership through the year from Brett Kaye and Alick Mazin, who like many in the arts-related fields, have been strongly tested during lockdowns. Senior Rabbi's report



ľm happy to report that after a long period of hardship with COVID lockdowns and restrictions, our Shule embraced warmly the resumption to normality when we could return to Shule - albeit with restrictions initially in October 2021. (Our highly anticipated, but 150th twice-postponed

anniversary Gala event eventually took place on 3 April 2022 and was well worth the wait.)

Once we were out of lockdown, as expected, the number of Simchas in our Shule rose significantly. There was a lot of catching up to do — and for the best of reasons. During lockdowns, some took place virtually.

For the entire year however, my main role never wavered, focusing predominantly on the pastoral needs of our congregation — which faced additional challenges during lockdowns — as well as education through regular shiurim which continued uninterrupted.

I have officiated at numerous weddings, Bar Mitzvahs, Bat Mitzvahs, Britot Milah, and unfortunately funerals and consecrations, as well as numerous other life cycle events. Getting to know Bat and Bar Mitzvah children in the lead up to their big day, as well as couples in the lead up to their weddings, has been and remains an important priority.

I've facilitated numerous Bar and Bat Mitzvah interviews to ensure each boy and girl are fluent in his/ her Parashah / Dvar Torah. I have unfortunately also had to attend bereavement visits and sick visits and I make an active effort to personally phone our members to wish Mazel Tov on births, engagements, weddings, birthdays, milestone wedding anniversaries and various other Smachot, as well as on sad occasions such as bereavements.

I have delivered weekly Shabbat sermons from the pulpit as well as sermons on the Chagim and have delivered weekly Shiurim on our Kabbalah for Beginners classes which is now in its 10th year. I continue to contribute to the Shule's weekly Shabbat Shalom newsletter with my "Rabbi Glasman Touches Base" pieces, informing our members of some of the things I get up to during the week. I continue to contribute material regularly to the Shule's social media pages regularly to ensure maximum reach, especially among our younger demographic.

This year we have continued our highly-successful weekly conversion classes by renowned educator David Solomon and attendance has been consistently high,

assisting those converting to Judaism as well as Jewish people seeking to enhance their knowledge.

Rabbi Hillel Nagel and I have continued to work together on fortnightly classes for our Bar Mitzvah group. These have been well attended and enjoyed with positive feedback from parents. Rabbi Nagel has been very supportive by officiating at various life-cycle events when I'm unavailable and he delivers numerous talks and Shiurim too.

The 'Minyan David', our daily Shacharit minyan, has been running for almost 16 years (including via Zoom when necessary) and is followed by a brief teaching from Pirkei Avot, Ethics of Our Fathers. This is an excellent achievement and of which we should be proud, especially as it allows mourners to recite the Kaddish in honour of their loved ones.

I maintain an active involvement in wider Jewish communal affairs having been President of the Rabbinical Association of Australasia for almost three years and Co-Vice President of the Rabbinical Council of Victoria for nearly one year. I continue to address communal forums and events when requested and sustain engagement with other faith communities. I have worked as a Human Research Ethics Committee member for the Royal Children's Hospital over the past year and have almost concluded my master's degree in counselling at Monash University. I view my continued involvement in the wider community and media appearances as important in representing St Kilda Shule, considered one of Melbourne's leading Shules, and I have received a lot of positive feedback to these activities. I was extremely fortunate appointed a Member of the Order of Australia in last year's Queen's Birthday Honours which I feel brought prominence and goodwill to the St Kilda Shule community.

Rebbetzin Sara continues to be an outstanding source of support in my work for the Shule through regular Shule attendance, participation in significant Shule events and functions, and most importantly through her many hours of pastoral care work which is always conducted "under the radar". I thank her sincerely.

I also thank our dedicated Board of Management led by Gerry Bullon and other volunteers who tirelessly devote themselves towards our Shule to ensure we have strong lay leadership and grassroots support for all the work undertaken by our rabbis and office staff.

Finally, I take this opportunity to wish you all a healthy and happy year with lots of naches from the people you love.

Assistant Minister's report



As I look back over the post-lockdown second half of past 12 months, I have been fortunate to be part of the very successful Bar Mitzvah and Bat Mitzvah programs, exciting youth and family events, engaging Talmud classes and adult education and numerous St Kilda shule simchas. I feel very privileged to work with

such an amazing team, supporting Rabbi Glasman, singing with the choir, working with the President, Board, Chazzan, CEO, office staff and the amazing team of volunteers — and of course, being part of our warm kehilla (congregation).

One of the highlights of my week at Shule is running the Bar Mitzvah program with Rabbi Glasman, which gives both of us and our Shule community a lot of nachas. Despite a crazy and uncertain few years, we have continued to see success in the classes, with growing numbers and an amazing variety of education and social experiences.

The Bar and Bat Mitzvah programs run alongside with other and we often join forces for different events. They give us the opportunity to connect with the Shule's youth and hopefully build long-lasting relationships as participants grow into young adults and enter the world as proud and knowledgeable members of the Jewish community.

A central theme of the curriculum is about giving to society, teaching participants about the role of a young Jewish adult in this world and the contribution that each can make. Therefore, the programs include volunteering at C-Care (preparing meals for disadvantaged members of the community); undertaking the 'Remember Me' course which teaches the Holocaust, genocide and human behaviour; and our weekly discussions on contemporary Jewish thought.

Another highlight of my week at Shule is our Talmud for Everyone shiur, which. allows us to gain a deeper insight into our laws and traditions. By analysing the sources, asking questions, arguing our points and sharing ideas, we learn new things and have a better understanding of Jewish laws and traditions and their purpose. We can take this ancient wisdom and make it relevant to our daily work and family lives. Some of the topics we covered this year included conversion, the origins of the siddur, belief in magic and healing powers, a tour of Jerusalem and science in Halachah. We also learned about the life and halachic decisions of Rabbi Chaim Kanievsky TZ"L, the leading Rabbi and Posek (legal scholar) of this generation who passed away in Israel on Purim this year.

Above all, being part of a wonderful community gives us a sense of purpose and belonging. Aside from our wonderful Shabbat, Yom Tov and daily services, St Kilda Shule offers so many events, activities and classes there is something for everyone.

Annual Report 2022

Events and Achievements

St Kilda Shule faced a second consecutive year punctuated by COVID-induced lockdowns, but we again rose to the occasion, continuing to connect with our community, shifting between to face-to-face and virtual presentations and activities as required. Among highlights were Rabbi Yaakov Glasman's fiveyear reappointment as Senior Rabbi; him being made a Member of the Order of Australia (AM) in the 2021 Queen's Birthday Honours; his and Rebbetzin Sara Glasman's 10th anniversary serving the Shule; and Rabbi Hillel and Rebbetzin Debbie Nagel's 25th year of service. Disappointingly, we were forced to postpone our 150th anniversary Gala event and the launch of our commemorative book three times (eventually taking place 3 April 2022).

All our regular activities including Shabbat and chagim services; Bat Mitzvah and Bar Mitzvah programs; Rabbis Glasman AM and Nagel's more-than 70 Shiurim; Rabbi Glasman's pre-marriage and Judaism introduction sessions; and Thursday Lunch Clubs (TLCs) continued, usually online. Rabbi Glasman was busier than ever with his pastoral work and his ambassadorship and advocacy activities in the wider Jewish and general communities.

Engagement with the Shule's Facebook page continued to expand for Shabbat and Festival services, including a growing local and international audience for pre-Shabbat singalongs as well as for special services including for Anzac Day and Remembrance Day. Shule leaders - past and present - participated in important community events including Yom Ha'atzmaut, Yom Hazikaron and Yom Hashoah. Non-Jewish school tours continued outside lockdown periods. Happily, Purim and Chanukah festivities fell between lockdowns and attracted enthusiastic crowds to Shule for all-age activities. On the social and cultural sides, we hosted a variety of events - face to face and virtually including our popular Trivia Quiz and the Whisky & Herring night as well as a panel discussion on initiatives to address the prohibitive cost for many families of Jewish education.

April



New look: Graphic designer Yitz Rapp redesigned the Shule's corporate branding with a new logo and colour palette for our 150th birthday year (above).

TLC live: Thursday Lunch Clubs featured guest speakers, Melbourne Jewish Museum (then Jewish Holocaust Centre) senior archivist Dr Anna Hirsh on 'Collecting the evidence of Holocaust survivor narratives'; and Rabbi Dovid Gutnick of East Melbourne Hebrew Congregation, a chaplain to the Australian Defence Force since 2009, who described his role and the driving ethos of the ADF — 'service and sacrifice'. **Remembering Holocaust:** Rabbi Emeritus Philip Heilbrunn recited Kaddish at this year's JCCV 'virtual' Yom Hashoah community commemoration titled 'Triumph of Survival'.

Israel Shabbat: We joined other Shules and Zionism Victoria for the annual Israel Shabbat service. Guest speaker was Shai Habet, a social change activist and former parliamentary advisor to Knesset Member Michal Rozin.

Around the community #1: It was a busy couple of weeks for Senior Rabbi Yaakov Glasman who recited Yizkor at the communal Yom Hazikaron commemoration; participated in the Yom Ha'atzmaut communal prayer services; and (as President of the Rabbinical Association of Australasia) with Rabbi Emeritus Philip Heilbrunn OAM (as President of the Rabbinical Council of Victoria) visited Government House to sign Victoria's official condolence book for the Royal Family's Prince Philip, Duke of Edinburgh.

VAJEX guests: Vice-President Janice Iloni-Furstenberg and CEO Rabbi Ronnie Figdor OAM represented our Shule at the Victorian Association of Jewish Ex and Servicemen and Women Australia's 160th ANZAC commemoration.

May



Glasmans renew: Among highlights of the month was the renewal of Rabbi and Rebbetzin Glasmans' contract for another five years (above from left: Janice Iloni Furstenberg, Rabbi Glasman, President Anton Block).

Disability in families: Earlier, we hosted a choral Shabbat service addressed by Jewish educator and inclusion advocate Tal Spinrad on 'Community inclusiveness: meeting the needs of families with children living with disabilities'.

Kosovo visit: The Shule welcomed a delegation of Kosovan young adults, organised by the Israeli Embassy in Canberra following the establishment of diplomatic relations between Kosovo and Israel.

Tikkun Leil guests: Our pre-Shavuot Tikkun Leil presentation, chaired by Rabbi Glasman, featured Mount Scopus Memorial College principal Rabbi James Kennard and mikvah operator and prison chaplain Timmy Rubin OAM.

The old Jerusalem: Thursday Lunch Clubs were addressed by Australian Jewish News religious affairs editor Yossi Aron OAM on 'Remembering pre-1967 Yerushalayim' at Thursday Lunch Club; and Burnie Kuran of the Australian Jewish Geneological Society (Vic) on 'The origins of Jewish surnames'.

Supporting Israel: Following Hamas attacks on Israel, we hosted a joint Shule prayer and solidarity gathering.



Youth meet: We hosted a Bnei Akiva Australia's firstever Gibushon (To combine) event, bringing together members of the religious-Zionist youth group from Sydney, Perth and Melbourne (above).

June

Lockdown #4: Melbourne went into its fourth lockdown, forcing services and events online again.

Special simchot: TLC featured a Jewish Care representative sharing stories about Bat Mitzvah and Bar Mitzvah for 90 residents who missed out during the Holocaust; and a mother of the bride describing how she raced to Israel for her daughter's last-minute midnight ceremony due to COVID restrictions.

Honouring COVID victims: Rabbi Glasman delivered a prayer and reflection in a multifaith event at Jewish Care in memory of COVID pandemic victims.

Queen's honours: Our Shule community was well represented in the Queen's Birthday honours, led by Rabbi Glasman who was made an AM (Member in the Order of Australia) for significant service to Judaism and interfaith dialogue, to rabbinical bodies and to the community. Former choirmaster Adrian Bartak received an OAM (Medal of the Order of Australia) for his service to music, as did James Ostroburski for service to the community through charitable organisations. Professor Stephen Davis was made an AO (Officer of the Order of Australia) for distinguished service to medical education, to stroke research and to the management of cerebrovascular disease.

Looking forward: Rabbi Glasman was interviewed for the *Australian Jewish News* virtual 'Future Jews 2048' program by futurist Morris Misel, playwright Joanna Murray-Smith and head of Moishe House, David Goldberg on 'Jewish assimilation — exploring the future integration of Jews into broader society and society's response to it between now and 2048'.

Memoir: Life Member and former Shule president (1982-1984) Michael Cohen OAM describes his family's 200-year Australian history in his book From Chains to Honours, launched by Federal treasurer Josh Frydenberg I at the Ark Centre before a large crowd which included a strong contingent of Shule members.

July

Welcome KMOW: Kosher Meals on Wheels (KMOW) moved its office and freezers into the Shule's Danglow Centre (storing food prepared offsite for distribution to needy recipients), joining other tenants, nut butter manufacturer Alfie's; vegan soup maker Three Daughters; and Nifla Kosher Catering.



New kitchen: We welcomed our new gleaming, stateof-the-art kitchen at the Adele Southwick Centre. Supported by a \$100,000 Victorian Government grant, the Shule financed the remainder of this major project, undertaken by commercial kitchen specialist Tony Schindler Consulting. The kitchen accommodates the needs of both in-house and external caterers featuring quality commercial appliances, top-grade stainlesssteel bench tops, sinks, splash backs and portable trolleys, plenty of storage space, and new cool room, and new windows, lighting and electrics (above: before and after).



Guest topics: This month's TLCs featured Rabbi Glasman, an Unchain my Heart ambassador, who discussed tackling Gett refusal; Rabbi Nagel (above) on 'The history of the Temple destruction and its relevance today', in the lead-up to Tisha B'Av; and spiritual mentor and Kabbalah teacher Rabbi Laibl Wolf on the soul and afterlife.

Advising police: Rabbi Glasman contributed to the content of an Australia New Zealand Policing Advisory Agency (ANZPAA) guide for police to assist them interact with the Jewish community.

Excellence awards: Shule members were honoured with prestigious awards. Board member Frank Tisher OAM, a property law specialist, received the Law Institute of Victoria's (LIV's) Distinguished Service Award for significant and distinguished service to the LIV or the legal profession over many years. Professor Natalie King OAM, a leading curator, writer and senior researcher engaged with artists and institutions across the Asia-Pacific, received the University of Melbourne's Patricia Grimshaw Award for Mentor Excellence.

Around the community #2: Rabbi Glasman joined Rabbi Nagel to welcome the new intake of Bar Mitzvah boys (and their parents) to our weekly Sunday program; participated in a public online conversation about Sydney's extended lockdown with Rabbi Dr Benjamin Elton of Sydney's Great Synagogue; and began a year-long Master's degree in Counselling at Monash University, which will benefit his work in pastoral care.

German honour: Shule member Garry Fabian was honoured by the German Government with the prestigious Verdienstorden (Order of Merit) of the German Republic, recognising his service to the citizens of Baden-Wurtenberg over many years. Baden-Wurtenberg Secretary of State Winifried Kretchmann nominated Garry for "sharing his experiences and personal story and building bridges of understanding".

August

Rabbis' posts: Rabbis Glasman and Nagel were elected President and Treasurer of the Rabbinical Association of Australasia, respectively.



New Year vibes: Getting into the 'Rosh Hashanah vibe', our Facebook page followers from around the world joined Rabbi Hillel Nagel, Chazzan Brett Kaye and choristers Isaac and Alex Itescu with the added attraction of a special tour of the Old City of Jerusalem led by guide Patrick Amar. Continuing the theme, we joined urban beekeeper and honey producer Jonathan Landes in his Caulfield garden to learn about the honey-making process and its relationship with the environment. The Shule joined Emmy Monash Aged Care for a Rosh Hashanah musical celebration with Brett Kaye and young choristers Isaac and Alex Itescu, broadcast live from Goldschlager Family Synagogue.

Generations connect: TLC guest Morris Tobias explained how Australian B'nai B'rith volunteers teach underprivileged Israeli students English online.

Jewish ed panel: We hosted a panel discussion titled 'Private Jewish day school education: can it be affordable for all? — rethinking the future of our Jewish Schools' 2021 Discussion Paper'.

Shule elections: Gerry Bullon was elected Shule President at our Annual General Meeting, succeeding

Anton Block. Our first ever female Vice-President (and acting Treasurer) Janice Iloni Furstenberg was re-elected unopposed. Recent new member Roslyn Gladwin joined the Board and Frank Tisher OAM and George Erchlister were re-elected for two years. Jay Greenberg was welcomed as new Treasurer.

September



High Holydays online: Disappointingly, for the second year in a row, our High Holydays services took place online due to COVID-safe restrictions, but as always, our ministerial and administrative teams excelled to produce meaningful song, prayer and words of wisdom for our Shule community. Our specially-curated Rosh Hashanah gift packs hand-delivered to all member households were well received (above), as were our special online videos for Succot.

Newsletter milestone: Fittingly, the September 3 edition of Shabbat Shalom, our last for the Jewish year, reached a record 1500 readers. The weekly newsletter was launched by Rabbi Heilbrunn in 1991; when Rabbi Figdor joined our Shule as CEO in 2012, it had nearly 600 subscribers — three years later, that number had grown to 1200!

Trivia goes virtual: Unable to host our popular Trivia Night face-to-face, organiser John Slutzkin moved the event online.



In the (solar) sun: Our Shule cemented its place in environmental responsibility by installing solar panels on its roof (above). "For us, going solar was a nobrainer. It makes sense environmentally and it makes sense economically. It is also our halachic duty to take measures that protect the environment and I am proud to be a part of a Shule that not only recognises this reality, but acts on it," Rabbi Glasman said.

Hillel's other hat: Away from Shule, Assistant Rabbi Hillel Nagel works at Ernst & Young as a corporate lawyer and governance adviser. Ernst & Young is one of Australia's largest professional services companies

and encourages diversity and inclusiveness in the workplace. The company hosted an online event for all Jewish employees around Australia in the lead up to the yom tovim, inviting Rabbi Hillel to explain the customs of the festivals and their importance to Jews in today's world. Rabbi Nagel surprised the group by arranging for Chazzan Brett to join and share some tunes for the holidays.

October

TLC guests: A diverse range of guests featured at this month's TLCs, kicking of the new year with Happy Hour led by wellbeing specialist Ros Ben-Moshe on 'Laughter: a New Year's resolution for resilience'. Two weeks later, Eddy Lichtig explained how he used his political contacts to help to obtain Australian humanitarian visas for young women activists in the soon-to-be Taliban-controlled Afghanistan.



Multifaith link: Rabbi Glasman met with religious leaders from the Catholic and Muslim communities (above) to share their experiences and hopes in reopening places of worship, discussing the impact lockdown on their congregations — spiritually, socially, psychologically and emotionally.

Centenarian: Our Shule community wished a hearty Mazel tov to long-time member Cecille Rees on her 100th birthday on 13 October.

Shabbat Project: St Kilda Shule was again at the helm of Australian celebrations for the 2021 global Shabbat Project. Rabbi Figdor organised an online communal Havdalah of the eastern states with Rabbi Glasman and Chazzan Brett Kaye joining Shule leaders from Melbourne, Sydney and Brisbane.

Vax centre: In a community-lauded initiative, the Danglow Centre became a walk-in vaccination clinic with Star Health providing COVID vaccinations for those 12 years and over.

Back in Shule: With lockdown lifted, we had much to celebrate, returning to Shule on Friday night, 29 October, but with strict conditions regarding density and vaccination.



Youth memories: Time stood still for an hour when the Shule's Danglow Centre reverberated with screeches of glee from six 60-somethings, transported back to 1974 and their "fun of a lifetime" at Synix Youth Group (above). A reunion of former Synix members and those from other youth groups was planned for 2023.

November

Remembering the fallen: Our Shule honoured our fallen heroes in a commemorative ceremony at the graveside of Sir John Monash in Brighton General Cemetery's Jewish section on 11 November. Monash was an active member of our Shule. Rabbi Glasman ended the service by blowing the Shofar (below).



Medico lauded: Top Melbourne researcher, clinician and long-time Shule member Professor Paul Zimmet AO was recognised in the American Diabetes Association's international medical journal, Diabetes Care, for his extraordinary contributions to the field of diabetes.

Trivia live: Around 130 trivia buffs returned to the Adele Southwick Hall for the highly-anticipated Trivia Night led by John Slutzkin after two years of online competitions.

RCH post: Rabbi Glasman added another string to his bow of important community involvements with his appointment to the Royal Children's Hospital Human Research Ethics Committee. He said it enabled him to give back to the Hospital where his younger brother spent much of his childhood for a chronic illness.

JC honour: Long-time Shule member Delysia Pahoff received Jewish Care's 2021 Leo and Mina Fink Community Service Award for founding and leading the Friends of Montefiore Committee for more than 38 years.

Unmasked as one: The month ended on a huge high with the reopening of Shule for Shabbat services, but with vaccination requirements.

December



Chanukah: Our family festival was a great success with around 100 people of all ages gathered on the Shule forecourt to enjoy festive food, music and activities (above). Festivities continued two days later when Rabbi Glasman represented our Shule and the Rabbinical Association of Australasia at a private Chanukah function with Jewish and non-Jewish chaplains of the ADF and Victoria Police.

Batmi/Barmi: It was an especially-exciting Shabbat morning graduation ceremony for the 2021 Bat Mitzvah and Bar Mitzvah Program participants who had navigated the upheavals of year-long lockdowns with mature aplomb.

Righteous Gentiles: Our Shule doors welcomed the Embassy of Israel and Gandel Philanthropy which cohosted a ceremony honouring two families who helped to save Jews during the Holocaust.

2022 January




More jabs: Our Shule hosted two more well-attended pop-up COVID vaccination clinics for adults and children (above).

March

The current Trustees of the Library Fund are Frank Tisher OAM (Chairman), Jeff Degen, Julian Black OAM, Selwyn Greenberg, Anthony (Danny) Goldsmith, Rabbi Yaakov Glasman and Luana Felber.

The weekly Shabbat Shalom is published both in print edition and online, boasting a more-than 1550 circulation. It is posted out each week to the older members who do not have an email address. The newsletter continues to be popular both with our own membership and the wider Jewish community (approx. cost \$8000) and its circulation has been maintained, particularly in the electronic version. The Trustees are very grateful for the continued support of Rosetta Bloom who generously sponsors the publication in memory of Nathan Baron and Alan Bloom.

The Library Fund maintains a library containing a diverse collection of books and memorabilia and supports our education programs and publications. It houses an impressive collection of Jewish music, in particular vinyl LPs of Chazzanut and 'Jewish'-related music. A large collection of Classical music was generously donated by Suzie Ehrmann, in memory of her late husband and former President Ephraim's collection.

Other activities of the Library Fund include:

- Publication of the 150th anniversary commemoration book which was launched at the 150th Gala High Tea;
- Housing of educational materials for the teaching of Hebrew, Jewish history, Jewish culture and religion as well as objects and art works of religious significance;
- Bat Mitzvah and Bar Mitzvah courses;

Property report

A grant request was completed and submitted to the State Government to help fund significant renovations, repairs and maintenance of the ASC Annexe and Succah. Significant works are planned within the scope of this project, including replacing the existing succah which has been deemed to be unsafe. The ASC annexe timber floor needs to be replaced before we can proceed with the installation of an operable wall (a partition that will separate the hall from the annexe). We were advised in early 2022 that funding would be provided, half from the Government with half (about \$100,000) to be funded through donations and other fundraising.

General repairs and maintenance:

- These were undertaken regularly by our diligent onsite caretaker Raymond Landes.
- United Fire Equipment continues to conduct biannual audit programs in an addition to an annual termite maintenance in the Samuel Meyers Hall incorporating the Adele Southwick Centre (ASC).
- The Secretary managed the heating, lighting, and arming / disarming the alarm for Shabbat and Chagim making the necessary changes for the occasional Shabbat afternoon call-up. It was ensured that these were automated for these occasions.

Venue hire:

Venue hire continues to grow as source of revenue but it was significantly impacted by COVID-19 lockdowns affecting Gymbaroo in the ASC (Tue-Thu during school term) and Australian Friendship Circle (each Sun and Sun-Fri during day camp). Nifla Kosher catering in half of the ASC kitchen (Sun-Fri) was affected as there were no Smachot for many months and they were not charged rental at that time. However, Alfie's Food Co continued its manufacture of nut butters in the ASC kitchen storeroom area and also rental of office space and storage. All Shule buildings are "access friendly" making them ideal for disability programs.

Soup manufacturer Three Daughters Food continued twice-a-week operations in the Danglow Centre (DC) kitchen throughout lockdown. Long-term tenants Kosher Meals on Wheels has office space and freezers with food manufactured offsite.

The Shule still played host to communal events, restrictions permitting.

Building works:

- The replacement of the front glass doors of the ASC for solid steel doors was finalised in April 2021.
- The ASC Kitchen had an extensive first-rate renovation, providing a higher-quality offering for Kosher Kiddishim, Simchas and various catering requirements.

Protective Services report

We are very grateful to our volunteers for being on call to stand on duty to safeguard our community. The Security Protection Team is led by Danny Goldsmith and Noel Levin OAM assisted by Lionel Walvisch.

Working with the Community Security Group (CSG), a Physical Risk Review was conducted and the priority recommendations are being implemented to ensure continual improvement of our security capability.

This past year has been another frustrating year. Organising the weekly roster and the specific roster for Chagim is time consuming. It requires contacting volunteers and checking on availability. For any shift, there may be two to three people on duty to ensure that no one is on duty for too long. The last-minute standing down of volunteers due to a sudden lockdown or the sudden easing of restrictions on a Thursday requiring an urgent roster for duty for that Shabbat, added to the stress of the administration of these teams. The Shule acknowledges the hard work and dedication of our Security Protection Team.

We continue to need more volunteers as regular services and special events have resumed from lockdown interruptions. Treasurer's report



Dear valued members and seat holders,

Another challenging financial year has passed, and I am pleased to report that the St Kilda Hebrew Congregation's financial position is strong and stable. Due to the unwavering support of our proud congregation, as

at financial year end (31 March 2022), I am pleased to report that the Shule will provisionally post a financial breakeven year, successfully executed in accordance with our forecast budget. In 2022, total revenue fell by 11.4% compared to the prior financial year, however seat and membership revenue grew by 2.5%.

This result was achieved despite another interrupted year, limiting income from bimah offerings, simcha bookings, venue hire and significantly reduced government support from state and federal sources. Despite restrictions, the Shule managed to maintain our loyal membership base. This result is a testament to the hardworking and resilient operations team, led by Rabbi Ronnie Figdor. After 10 years at the helm, Rabbi Figdor decided the time was right to move onto new opportunities, and we thank him for his dedication and commitment to achieving a history of financial success for the organisation.

In response to increasing cost pressures throughout the economy, the Shule has instituted a modest price increase to membership and seat fees. Membership fees have risen from \$375 to \$395 per annum, whilst seat fees have risen across the board by an amount that overall should not exceed 3%. Membership and seat rental fees are the financial lifeblood of our Shule, and the board very much appreciates your understanding and support on this matter.

Upon review of our published financial statements, you'll note that at 31 March 22, our balance sheet is strong, reporting a significant net asset surplus. Cash reserves have been mostly maintained during the year, however debtors have increased, no doubt due to the depressive impact of COVID on our members. We are materially debt free and have reduced significant employee statutory liability provisions throughout the financial year.

I am pleased to report that we have engaged an independent third party wealth manager to assist us with managing our capital reserve in order to provide an improved yield on our reserve funds that were previously earning very little interest in bank term deposits. These funds will be invested strictly in accordance with the Shule's Investment Policy, that dictates an extremely conservative risk appetite and strong board oversight.

Looking ahead to the 2023 financial year, we anticipate significantly less interruption and a return to Shule operations as usual. In an effort to maintain our relevance and appeal to the community and existing membership base, the Shule, with the generous support of public and private assistance, has embarked on a

much-needed capital investment programme. Capital investment projects that we expect to begin within the 2023 financial year include:

- Renovation of all bathroom facilities on premises
- Restoration of the Adele Southwick Centre annex
- Playground installation, next to the annex
- Expanded yahrzeit boards
- Physical security improvements
- Extended security camera coverage

As a result of increased expenditure, the 2023 budget conservatively forecasts a small loss, with the intention to return to surplus in the 2024 financial year.

Finally, in late 2022 the Shule office team welcomed a new Executive Director, David Marlow. I am pleased to report that David has integrated seamlessly with the existing financial and operational systems at the Shule. I look forward to working further with David, his team and the board in delivering the 2023 budget and maintaining the strong financial health and performance of this wonderful organisation.

Notes to the Financial Statements

1 Summary of Significant Accounting Policies

(a) Basis of preparation

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the *Australian Charities and Not-for-profits Commission Act 2012* and the *Associations Incorporation Reform Act (Vic) 2012*. The committee has determined that the Association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of these financial statements.

(b) Income tax

No provision for income tax has been raised as the association is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

(c) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

Property

Freehold land and buildings are valued at independent valuation.

In the periods when freehold land and buildings are not subject to an independent valuation, the management committee conduct committee's valuations to ensure the land and buildings' carrying amount is not materially different to the fair value.

Increases in the carrying amount arising on revaluation of land and buildings are credited to an asset revaluation reserve in equity. Decreases that offset previous increases of the same asset are recognised against the asset revaluation reserve in equity, all other decreases are recognised in the income statement.

Any accumulated depreciation at the date of the revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Plant and equipment

Plant and equipment are carried at cost less, where applicable, any accumulated depreciation, except the Sefer Torahs.

Depreciation

The depreciable amount of all fixed assets including buildings, but excluding freehold land, is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

1 Summary of Significant Accounting Policies

(d) Impairment of assets

At the end of each reporting period, the management committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income statement.

(e) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held on call with banks and other short-term highly liquid investments.

(f) Accounts receivable and other debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(g) Employee provisions

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(h) Revenue and other income

The incorporated association recognises revenue as follows:

Memberships & Security Levies

Membership and security levy revenue are recognised over time, when performance obligations have been satisfied to members.

Sale of goods

Revenue from the sale of goods is recognised when the performance obligation is satisfied, generally at the time of delivery

Donations and bequests

Donations and bequests are recognised as revenue when the right to receive them is established and amounts can be measured reliably. Donation Income is recognised in accordance with AASB 15, if the contract is enforceable and has sufficiently specific performance obligations. Donation Income without specific performance obligations is recognised under AASB 1058

1 Summary of Significant Accounting Policies

(h) Revenue and other income

Government grants

Government grants on the condition that specified services are delivered, or conditions are fulfilled, are considered reciprocal. Such grants are initially recognised as a liability and revenue is recognised as services are provided or conditions fulfilled. Revenue from non-reciprocal grants is recognised when the association obtains control of the funds.

All revenue is stated net of the amount of goods and services tax (GST).

(i) Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

(j) Accounts payable and other payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

2 Critical Accounting Judgments, Estimates and Assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Estimation of useful lives of assets

The incorporated association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Employee benefits provisions

As discussed in note 1, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

Report on the Audit of the Financial Report

Qualified Opinion

We have audited the accompanying financial report, being a special purpose financial report of St Kilda Hebrew Congregation Inc. (the Association), which comprises the balance sheet as at 31 March 2022, the income statement, the statement of changes in equity and the cash flow statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the statement by management committee.

In our opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* section of our report, the accompanying financial report of the Association is in accordance with Division 60 of the *Australian Charities and Notfor-profits Commission Act 2012* and the *Associations Incorporation Reform Act 2012 (Victoria)*, including:

We draw attention to Note 1 of the financial report, which describes the basis of accounting. The financial report is prepared to assist the Association to satisfy the financial reporting requirements of the *Australian Charities and Not-for-profits Commission Act 2012* and the *Associations Incorporation Reform Act 2012 (Victoria)*. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.
